If agreed, I will send an additional invoice for the additional work along with the updated drawings.
- 2.5. Invoices should be paid within 14 days of the drawings completed to your satisfaction. If payment is not received within this time I may refuse to undertake any further work for you or your company.

#### 3. <u>Responsibilities</u>

- 3.2. I will not take responsibility for any failures of items or equipment manufactured from my drawings that may result in damage or injury.
